REGULAR MEETING – 4:00 PM

Present: Mayor Grimshaw, Trustees: Emery, Harter, Linerode, and Hotchkiss, John Power, William Hamacher, Marcia Delong, and Matt Halsey.

Mayor Grimshaw opened the Public Hearing on proposed Local Law #2 of 2025 entitled “Establishing a twelve-month moratorium on Food Trucks” at 4:00 pm. After a brief discussion the hearing was closed on motion of Trustee Hotchkiss, seconded Trustee Linerode, all aye at 4:15 pm. No public comment.

Mayor Grimshaw called the regular meeting to order at 4:15 pm.
